General Information

The Canton Preservation Society's Preservation Award honors noteworthy preservation projects in the greater Canton Area which have recently been completed. These awards are an opportunity for the Society to recognize the efforts of property owners and the often heroic work they perform in preserving the historic and architectural resources in our area. The awards also encourage historic preservation and acknowledge that good preservation can be found in the restoration of the most modest residence to the grandest mansion. Award categories are as follows.

Private Residence: This category is for structures owned by an individual or a family and used primarily as a residence.

Commercial Property: All types of commercial properties are included, including rental properties, industrial facilities, etc.

Adaptive Use: This category is for structures that although meeting our guidelines have been modified for a use differing from the original.

The guidelines for the awards include consideration of sensitivity to the historic integrity of the building and its site, the preservation/restoration of a structure or landscape, and the skill of the craftsmanship. Properties must be at least 50 years old to be eligible. Historic preservation includes a broad category of activities, such as stabilization and conservation, restoration, adaptive use, strategic planning, policy making, public programming and much more. All of these activities will be considered during the judging.

Submission Process

- 1. Any person or entity may complete the Nomination Form even if he/she does not own the property. The Nomination Form must be completed and submitted to the CPS office by the deadline stated above.
- 2. After the submission date, the Awards Taskforce will study the entries and select one or more finalists in each category for submission to the Board of Trustees. The Awards Taskforce will then contact the Property Owners for possible additional information, photographs, and/or a tour before presenting the finalists to the Board of Trustees.
- 3. The Board of Trustees will consider the nominations and will make the final selection. The recipient(s) will be announced at the Annual Membership meeting.
